Detected Contaminants

The East Boulder County Water District routinely monitors for contaminants in your drinking water according to Federal and State laws. The following table shows all detections found in the period of January 1 to December 31, 2013 unless otherwise noted. The State of Colorado requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year, or the system is not considered vulnerable to this type of contamination. Therefore, some of our data, though representative, may be more than one year old. Violations and Formal Enforcement Actions, if any, are reported in the next section of this report.

Terms and Abbreviations

- **Action Level (AL)** – the concentration of a contaminant, which, if exceeded, triggers treatment and other regulatory requirements.
- **Parts per million = Milligrams per liter (ppm = mg/L)** – One part per million corresponds to one minute in two years or a single penny in \$10,000.
- **Parts per billion = Micrograms per liter (ppb = ug/L)** – One part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.
