Mark Johns called the meeting to order at 4:04 PM. Those in attendance were the board members Rick Moeller, Bill Hofgard and Bob Champ. Mary Wagner (Bookkeeper) and Peter O'Brien (Boulder Water Well) were also present. Yvonne Gates, prospective board member was also present.

PUBLIC COMMENTS

Yvonne Gates was present to be appointed to Lynne Deane's vacancy and take the oath of office.

SECRETARY'S REPORT

The minutes of the 12 January 2015 meeting were discussed. Bill Hofgard made the motion that we approve the minutes of the 12 January 2015 meeting. Rick Moeller seconded the motion, which was approved unanimously.

The following are the activities during this period. Activities performed through February 6, 2015 have been billed to the District.

Action Items

This section identifies any issues that require Board action or decisions. The issue(s) are summarized here, with details in the appropriate section of the report.

1) Noise noted when pump(s) downstairs shutoff.

General IT Consulting Activities

- 1) Website Maintenance
 - a) Published the January 12, 2014 Meeting Minutes.
 - b) The December 2014 Financials and the 2014 Year End financials have not yet been received to publish on the website.
 - c) Published the February 9, 2015 Meeting Agenda.
 - d) The Consumer Confidence Reports (Water Quality Reports) from the City of Lafayette now have links from the District's Archive pages. Lafayette had changed the mechanism for referencing their reports and broke most links. Reports were found going back to 2002, so all CCRs that affect the District have been identified and are available through the Archives.

The cable modem and the router were restarted.

Operational Support

 Verified both phone extensions. The main level extension (2) is working properly. The lower level extension (21) is not working and marked "Offline." Called Phone.COM technical support and tried to resolve the issue, without success. The trouble ticket has been elevated to higher-level support for further follow-up, most likely on Monday, February 9, 2015. It is possible that there is a physical phone failure, in which case the Board will be notified.

General Support

1) The 2015 Transparency Notice of Electors was updated on the website prior to the January 15, 2015 deadline.

New Issues or Comments

1) Did notice during the time system maintenance was being performed that when the downstairs pump(s) shutoff, there was a hard "kurchunk," like it was "hammering." This noise has not been noticed before, as I recall.
