Mark Johns called the meeting to order at 4:01 PM. Those in attendance were the board members Rick Moeller, Bob Champ and Bill Hofgard. Mary Wagner (Bookkeeper) and Peter O'Brien (Operator) were also present. Yvonne Gates was absent (excused).

PUBLIC COMMENTS

SECRETARY'S REPORT

The minutes of the 9 May 2016 meeting were discussed. Bill Hofgard made the motion that we approve the minutes of the 9 May 2016 meeting. Rick Moeller seconded the motion, which was approved unanimously.

FINANCE REPORT

Mary Wagner had e-mailed the financial packet to the board (Income & Expenses - annual budget vs. YTD actual, P&L YTD comparison, Income & Expenses by Month, Balance Sheet and the transaction report). Mary also e-mailed the water usage comparison spreadsheet.

Water usage is now increasing thereby water revenue was up last month. Mary will also submit the necessary election documents to the Division of Local Governments. A tax payment from Boulder County was also received.

Mary went through the transactions and the financial statements and the board approved the transactions.

Peter noted that he talked to the homeowner regarding filling the ruts to the pump house with road base and the homeowner agreed that it would be okay. NEW BUSINESS

WATER RATE HEARING

Mark Johns made the motion to open the Water Rate Hearing. Bill Hofgard seconded the motion, which passed unanimously.

The water rates have been raised by 5% by the City of Lafayette for the next five years (through 2021). It has been the Board's position that any increase by Lafayette is passed on to our customers. We have, in the past, left the operation portion of the base fee alone. However, with increasing costs and aging infrastructure, it was deemed justifiable to increase that portion of the base fee by the 5% factor as well. This also means that the standby fee will also increase by 5%.

Mark Johns thereby made the motion that the district increase the base fee and the standby fee as well and all the water rates by 5% per year, using 2015 water rates as the baseline, beginning with the July usage, through 2021. Rick Moeller seconded the motion, which passed unanimously.

Nick will create the new water rate spreadsheet, which will be provided to our customers.

Bill Hofgard made the motion that we close the Water Rate Hearing. Rick Moeller seconded the motion, which passed unanimously.

CCR REPORT

The dates on the CCR report were erroneous and will be changed. The link to the report will be included in the upcoming billing.

LEAD AND COPPER TESTING

Peter will conduct the lead and copper testing this summer. This is done every three years and has come to increased attention due to the episode in Flint, Michigan. Lead solder may have been used in homes built prior to 1982 so a sampling of those homes in the district will be tested.
