Bond Hearing March 6

As required by law, we will hold a public hearing on March 6th to discuss and adopt a resolution issuing the District's bonds. The meeting will be at 4pm and will be held in the "library" of St. Ambrose church. If you are interested in giving your opinion or you just want to see what all the fuss is about, please attend!

Bonds Offered

The District's bonds are "municipal" bonds that are free from federal and Colorado taxes. We have made special efforts to ensure that district residents and other interested individuals have the first chance to buy these bonds. George K Baum & Company, the bond underwriter, has made a member of its sales staff available to answer questions about this bond issue. If you want information please call Mike Pietrafeso at George K. Baum & Company, 303-292-1600. The bonds will be non-rated general obligation bonds of the District secured only by the taxing ability of the District. There will be various maturities ranging from three years to twenty years. Any bonds that are not sold to residents by the morning of March 6th will be sold on the open market, so if you are interested you will need to act quickly.

As with any investment, you should read the materials carefully and, if necessary, consult with your attorney or tax adviser before investing or sending money.
