# **Expect Completion 8/31**

The Board has approved an extension of the time the contractor has to complete the water system to August 31, 2001. The contractor has accepted numerous change requests and has even recommended improvements to the plan which have saved us money. There have also been issues with worse than expected utility locations and weather.

# Community Meeting

We will have a Community Meeting on August 15 at 7:00 pm at St. Ambrose. A brief presentation on the water system status will be followed by question-and-answer time. This will be our last community meeting before system completion.

## Panorama Park

The Panorama Park Mutual Water Association was dissolved on July 1. EBCWD will operate the PPMWA system until the new system is completed. Billing and operations will be unchanged, as will the flag system for system status:

- Red no outside watering;
- Yellow limit outside watering;
- US Flag all OK.

# **Getting Connected**

Many of you have asked about the detailed mechanics of connection. Here is a summary depending on your current water source. Note: "service line" means the connection from the meter to your house.

Apollo customers and customers with individual wells will receive a meter that is connected to the EBCWD main. After water is turned on to that meter, your plumber or contractor can connect a new Type K copper service line to the outlet side of the meter.

Benchmark customers will receive a meter that is connected to the present Benchmark main on one side and to the service line on the other. When the new system is complete, we will switch the Benchmark main to the EBCWD supply.

Panorama Park customers offer us the greatest opportunity for engineering creativity<sup>©</sup>. We will temporarily connect the PPMWA main with the EBCWD main so that the PPMWA pumps will provide pressure to both mains. The contractor will then go from house to house switching your meter inlet connection from the PPMWA main to the EBCWD main. Expect to have water shut off for four to eight hours during that day. Once all the meters are connected we will switch the outlet of the pumps to the EBCWD main and abandon the PPMWA main.

In particular, note that service lines must be Type K copper, they must be connected to the meter by a licensed plumber or contractor, and crossconnections with other water supplies such as individual wells are prohibited.
