Billing Frequency

We plan to reduce our meter-reading costs by reading meters and billing only every two months except in summer. Until we have built up some historical data, we will assume your usage is evenly spread across the two months.

Instead, please call our operators in the order listed at left. If both of them are unavailable please call a board member, also in the order listed at left. This procedure will help us get your problem solved more quickly.

Hydrant Testing

Our first hydrant tests with Cherryvale FPD were successfully conducted November 12. The hydrants are spaced so that no house is more than 1000 feet from a fire hydrant. You may notify your insurance company and request a rate evaluation. Depending on the insurer, this may affect your rates.

The meters and hydrants may not be painted or adjusted without consent of the district. Please make sure that the meters and hydrants are accessible.

Making Connections

If you need to make a service connection to the meter, or adjust your connection, please contact our operators before doing the work. This is important because it protects you (or your contractor) from claims of damage to district equipment, should any arise.

Final Clean-Up Items

To the best of our knowledge, only a few items remain to be done by our contractor before they receive their final payment. The matter of reseeding bare spots is separate: we intend to inspect the pipeline route in the spring and decide what sections should be reseeded. If you want to nominate a spot for special attention, please notify a board member.

If a repair item you are concerned about is not on this list, it means either we never knew about it or we consider it complete. Please contact a board member to discuss any issues.

- 535 Apollo: Reconstruct driveway to homeowner satisfaction.
- Lot 7 Paragon: Remove trash and restore to homeowner satisfaction.
- 7538 Spring Dr: Replace mail-
- 7555 Spring Dr: Replace damaged evergreen shrub, if required by homeowner, in springtime.
- 7274 Panorama: Patch asphalt pavement to original width in front of mailbox.
