## Storage Tank in Operation

On June 9, 2005, the 100,000-gallon storage tank went on-line and is now servicing the district. This is the first major capital improvement of the District's infrastructure since the initial construction. The contractor selected completed the project within schedule and estimate. The water provided now enters the District's storage tank and is gravity fed to the pump house on Spring Drive for distribution throughout the District. The 100,000 gallons provides a good reserve for handling a fire.

Special acknowledgement and thanks go to District Operators Frank Hauke and Dick Winters for their monitoring of the construction and design changes required and Director Mark Johns for his Program Management of the entire effort as well as Project Management from the District's perspective.

## Pump House Signal Light

A white strobe light has been installed in the window of the Pump House. This light will go on if the water level within the storage tank falls below a certain level. *If the light is seen flashing, please notify either of the System Operators or any of the Directors (contact information is to the left on this page).*

## Customer Code on Payments

To ensure the accurate recording of a payment for water service, standby fee, tap fee, etc. please ensure your Customer Code is on the payment. This can help reduce District operating costs by reducing the amount of time required by the District's bookkeeper.

## Landscaping Over Meter Pits

During the monthly meter reading, it has been noted that several of the meter pits have been buried under new landscaping.

Per Rule 8-1-7 *Right of Way/Easement Violations*, the District is not responsible for any damage to landscaping, or the restoration of landscaping, in the event of having to perform maintenance. Property owners are encouraged to not cover, or otherwise obstruct meter pits.

Even though the water itself originates with the City of Lafayette, the City cannot provide you with information about our system or our bills. *Please contact a system operator in advance of closing to schedule a final meter reading.*
